4. Description of participation in other non-profit organizations, other than the nominating organization.
5. Evidence that the project(s) can serve as a prototype for others, or is easily replicable in other communities.

Instructions and Policies:

1. **Eligibility:** Immediate family members of individuals who are current Board members of The Community Foundation of Carroll County, and prior Philanthropists of the Year award recipients are ineligible for this nomination. Nominee must be 18 years or younger on June 1, 2008.
2. **Completeness:** Nomination must respond to each of the five (5) award criteria outlined above, in no more than three (3) typed pages. Submissions which fail to address all five (5) criteria, completely and accurately, or that rely primarily on supplemental materials such as resumes, newspaper articles, annual reports, etc. will not be considered.
3. **Supplemental material:** A maximum of three (3) supplemental pages will be accepted with each nomination.
4. **Format:** All submissions must be transmitted via e-mail by the deadline to *nominations@carrollcommunityfoundation.org*. In addition, one (1) printed copy must be sent vial standard post to the offices of the Community Foundation by the submission deadline (see below). Supplemental material, if any, must be attached as PDF scans to e-mailed submissions.
5. **Deadline:** Nomination packages must be received by the Community Foundation of Carroll County no later than **Tuesday August 31st 2010**
